



American Red Cross Lifeguard Training



The Lifeguard Training class is designed for new lifeguards or for a person who's lifeguard certification has expired. If your certification is still current, but will expire soon, you can take the Recert Class. Each participant who successfully completes all class requirements will receive a Lifeguarding/First Aid/ CPR/AED certification which is valid for 2 years.

\$75 per person; for re-certifications (Code: LGT217)

Registration and Class Requirements

1. Complete the registration form, return with payment (check or cash—checks are preferred) & proof of age to:

Registration fees will not be processed until the participant has passed the Water Skills Test.

2. Attend one of the Water Test days at Memorial Park Swimming Pool (New lifeguards only - those registered for the recertification class will take their swim test the first day of class):

Saturday, March 18 9-10a

Monday, March 20 3-4p and 4-5p

Each participant must pass the water skills test to be allowed into the Lifeguard Certification Class. See reverse side for the water test requirements.

3. Attend all days and times of the lifeguarding class. There are skills and written tests throughout the class that must be completed successfully to receive your certification.

Additional Registration Information

Registration Deadline: March 17, 2017

Refunds: There are no refunds on program fees unless the class is cancelled. Once a participant has passed the water skills test and the payment is processed, there are no refunds, even if you do not pass the class.

Priority registration will be given to those who have applied to work at the Nevada City Pool or with Northern Sierra Swimming.

Participants must be at least 15 years old by the last day of class. **Proof of age must be presented with registration** (birth certificate, driver's license, etc).

Water Skills Test Requirement

The test will take place prior to the first day of class. Each participant needs to attend one of the dates listed on the front of this flyer. To pass the water skills test, participants must pass all 3 of the following objectives:

1. Swim 300 yards continuously demonstrating breath control and rhythmic breathing. Candidates may swim using the front crawl, breaststroke or a combination of both but swimming on the back or side is not allowed. Swim goggles may be used.
2. Tread water for 2 minutes using only the legs. Candidates must place their hands under the armpits.
3. Complete a timed event within 1 minute, 40 seconds. Starting in the water, swim 20 yards. The face may be in or out of the water. (Swim goggles are not allowed.) Surface dive to a depth of 6 ft, swim 10-15 ft along the bottom to retrieve a 10-pound brick. Return to the surface and swim on the back to the starting point with both hands holding the object at the surface and the face remaining at or near the surface or able to get a breath. Candidates cannot swim the distance underwater.

I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of my death or any injury or property damage that I may sustain while participating in said activity.

PARENTAL CONSENT: I hereby consent that my son/daughter, named above, participate in the above activity, and I hereby execute the above Agreement, Waiver and Release on his/her behalf. I state that said minor is physically able to participate in said activity. I hereby agree to indemnify and hold the persons and entities mentioned above free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of the death or any injury or property damage that said minor may sustain while participating in said activity. I agree that in the event that said minor requires medical treatment while under the supervision of City of Nevada City and Northern Sierra Swimming personnel in connection with described activity, such supervisor may authorize treatment.
