Directions will be given during the meeting to assist you on how to make your comments, but here are some things to know in advance:

- a. You will not be able to change your name once you join the meeting, so be sure to set that prior to signing onto the meeting.*
 - b. When you want to speak on an item, you will need to “raise your hand”. So look for that at the bottom of the screen and be sure you know how to that prior to the time that you actually want to speak.*
 - c. When you are given permission to address the Committee you have 3 minutes to speak (unless the Chair informs us otherwise during the meeting). Your video will not be turned on. The Commission will only be able to hear your voice.*
